The TIQM Certification Program requires a minimum of 11-13 days of in depth training in the processes of the TIQM Quality System coupled with Practicum projects in each required TIQM process. Courses IQ 101 **OR** IQ 130 **OR** an acceptable equivalent are pre-requisite courses for IQ150 and above.

There are four categories of concentration in the TIQM Quality System Certification:

- 1. Certified TIQM Professional in Information Quality**
- 2. Certified TIQM Professional in Information Resource Quality**
- 3. Certified TIQM Professional in Data Warehouse and Business Intelligence Quality**
- 4. Certified TIQM Manager in IQ Management and Leadership**

Certification also requires documentation of the execution of TIQM Practicum initiatives in which the TIQM Certification Candidate exhibits competency in the respective TIQM processes. All documentation submitted is held in strictest confidence under a confidentiality agreement. TIQM Quality System course and practicum requirements are listed on the next page for each certification. ***All practicum documentation must be submitted within twelve months of completion of the last TIQM Certification course.***
